- All persons must be 21 years and above to operate the jet ski by themselves
- All persons below the age of 6 may not participate in watersports activities
- All equipment rented must be returned in the same condition it was issued
- All equipment rented must be returned at the specified time
- All damages or losses to rental equipment will entail corresponding charge
- All persons agree to behave in a considerate manner and in such a way so as not to cause harm or danger to themselves or to any other person
- No persons must participate in sea going or water related activities under the influence of drugs and alcohol
- Should any activity be cancelled due to guest behaviour causing harm or danger then no refund will forthcoming
